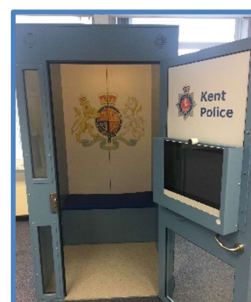

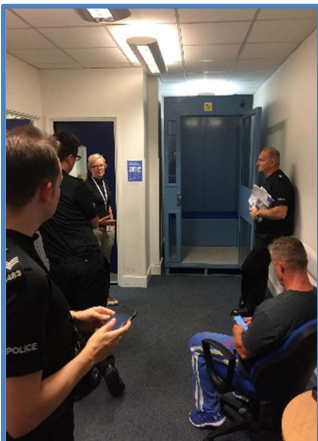
Building requirements - The Safebooths Range is built for simplicity; it needs two 13 amp power sockets and an ethernet point or Codex for your internal network. Designed with flexibility and change in mind, we recommend installation inside existing interview or consultation rooms, supported by CCTV. The built-in fans ensure Safebooths take on the temperature of the surroundings they are installed within.

Safebooths dismantled and relocated wherever you need them next. As technology develops, new conferencing endpoints can be simply installed. They “plug and play” on your internal network whatever system you operate.

Dimensions and Standards - The Safebooths Range all weigh in at approximately 600kgs. Guaranteed 100% ligature free, they meet National Police Estates Group (NPEG) standards and have been developed in partnership with the Video Enabled Justice Programme (VEJ), meeting the exacting requirements of HMCTS / Policing and the Ministry of Justice.

The Safebooths Range complies with BS EN 1090-1: 2009 & A1: 2011 and ISO 9001 and holds UK patent GB 2502041. At 2250cm tall, 1500cm wide and 1200cm deep, Safebooths will fit inside most standard rooms, offices, or even redundant cells. The safety glass doors are DDA compliant at 900cm wide. A compassionate solution to short term holding for Police, Prisons and Courts where you need to hold a person in safety for short periods, whether whilst investigating, searching or awaiting a private consultation or virtual court hearing.

Guaranteed 100% ligature free, each STH Safebooth comes factory fitted with 360-degree internal CCTV recording audio and video, ensuring the safety of the user always.

Robust, strong and vandal-proof throughout, the safety glass door and panels promote a calming environment, reducing the stress of staff and users, encouraging the earliest possible removal of physical restraints such as handcuffs. Early removal from physical restraints has been shown to reduce injuries and complaints making the operating environment more user focused.

The STH Safebooth comes fitted with a slam-shut keyless lock for simplicity and ease of operation.

Consultation Safebooth

Safe & private virtual operations

This is a robust, compassionate and safe solution for Police, Prisons and Courts, providing a private environment for remote consultations in a 100% ligature free Safebooth.

No internal CCTV is supplied with the Consultation Safebooth. We recommend installation within existing interview or consultation rooms and can supply CCTV outside the booth on request for remote monitoring reducing staffing levels. Observation is provided by the safety glass door and front panels.

Benefits include speeding up investigations, answering HMICFRS and Health & Safety criticisms, supporting virtual court processes or consultations in privacy, allowing a defendant to step outside the Virtual Court Room (VCR) to take legal instructions without disrupting the court process.

The Consultation Safebooth will save time waiting for legal representatives by allowing detainee consultations to be conducted remotely (voice or video) from a solicitor's chambers or elsewhere out of hours.

Investigators can conduct remote evidential interviews with a solicitor and interpreter joining on split screen, protecting everyone from infection. Inspector or Superintendent (or equivalent) can conduct PACE authorities remotely removing the need for travel whilst, ICV's can remotely monitor detention conditions privately with social distancing assured strengthening community confidence in your operations, providing independent oversight.

The Consultation Safebooth is cabled with power supply and data feed (ethernet / HDMI etc) to match your systems requirements and the end point of choice for your organisation, in a rugged cradle operated from outside the booth by your staff, removing the risk of willful damage, meeting the requirements of the VEJ Programme, PCVL and JVS systems and NPEG, MoJ, and HMCTS standards.

The Consultation Safebooth comes with a range of locking options for simplicity and ease of operation.





Live-Link Evidence Safebooths

The Evidence Safebooth is a robust and flexible solution for Police, Prisons and Courts (or any organisation giving remote evidence) where evidence can be provided to the court by a witness in an agile and 21st century format, socially distanced to assure protection from cross infection.

Evidence Safebooth provides a comfortable, private space, where witnesses can give evidence to a Court or Tribunal on oath (where applicable) from the remote location of your choice. A Patrol or investigation base, police station or vulnerable witness suite? The flexibility offered by the Evidence Safebooth means you decide where it will bring greatest efficiencies whilst protecting users from cross infection. This booth does not have internal CCTV installed.

Opportunities for efficiency include financial crime teams, where investigators travel long distances to make applications, or off-site, discreet locations, supporting vulnerable or protected witnesses.

Each Evidence Safebooth is supplied with power, ethernet, HDMI or cabled to your requirements, fitted with the end point system of choice for your organisation, in a cradle simply operated from within by the witness or usher.

The Evidence Safebooth comes fitted with an opening door from both sides, making it comfortable, private and very simple to operate.

The Virtual Court Room (VCR)

Each VCR is built ligature free, bespoke to joint requirements, in consultation with your local Judiciary. Fitted with comfortable, fixed bench style seating with robust cushions, the VCR is designed to ensure the safety and accommodation of up to 5 of persons, to include interpreter, dock officer and escorts if required.

Each VCR is cabled with power ethernet, HDMI or cabling of choice, fitted with an externally mounted end point system of choice for your organisation, internally viewed through toughened safety glass. Simply activated from outside the room by your staff for the court clerk to control for the hearing.

The VCR comes fitted with card reader entry system for both entry and exit, providing a safe, secure and simple to operate door entry system.

The VCR is completely ligature free and can safely hold a disruptive subject, allowing all other persons to withdraw without the need for restraint reducing risks. The minimum dimensions for a VCR are 2250cm tall, 2100 cm wide and 2100 cm deep. Please ask us to visit and discuss your individual requirements.
